1. Introduction

This Year 2 Action Plan implements the second year of activities that will address the goals established in the City of Scottsdale 2025/2029 Consolidated Plan. The term of this Year 2 Action Plan is from July 1, 2025, through June 30, 2026.

The target populations identified in the Consolidated Plan are seniors, persons with disabilities, families with children and youth under 18, victims of domestic violence, adults in crisis, and the homeless. The Consolidated Plan also addresses persons in need of obtaining affordable housing.

Over the next year, the need for programs and services for the target populations identified will continue to grow. The City of Scottsdale is committed to providing critical services through continued programs with available resources.

Potential opportunities and challenges during this fourth year include:

- Significantly increase Scottsdale Cares donations
- Increase in the demand for basic services offered through the community centers, senior centers and Housing Community Assistance

The City's goals and objectives to meet the needs of the community are:

- Administer housing, human services, and community development resources to provide opportunities to low and moderate-income people for safe and sanitary housing, self-sufficiency, social services, economic growth, and reasonable accommodations for persons with disabilities.
- Leverage a variety of state, local, and private resources, including the coordination of volunteers, to respond to human service needs and provide opportunities for people to connect to each other and to the city through social and recreational interaction, volunteering, and emergency and support services.
- Partner with various non-profit service providers to assist the needs of the community.

2. Summarize the objectives and outcomes identified in the Plan

The key strategic objectives outlined in the Consolidated Plan and proposed to be addressed in this Year 2 Action Plan include:

- Administer housing, human services, and community development resources to provide opportunities to low and moderate-income persons
- Increase the quality of owner-occupied housing through Major Housing Rehabilitation assistance to low and moderate-income households
- Preserve and improve habitability of owner-occupied housing through emergency home repair and roof repair assistance
- Preserve affordability of quality rental housing through the Housing Choice Voucher (HCV) Programs and Specialty Vouchers that include, EHV, FYI and VASH.
- Provide affordable rental housing opportunities through City-owned multi-family housing.
- Participate in and support the regional Continuum of Care efforts to serve the homeless through financial support to:
 - Local providers of transitional housing
 - Local emergency facilities for victims of domestic violence
 - Regional shelters for the homeless
 - Intake and referral
 - Emergency rent, mortgage and utility assistance
 - Promote self-sufficiency, through the Family Self-Sufficiency Program (FSS)
 - Provide funding assistance through Subrecipient and Professional Service agreements to non-profit providers of services to Scottsdale's youth, seniors, special needs populations, victims of domestic violence, persons and families in crisis, and disabled persons
 - Improve quality of life through resources and referral services
 - Provide access to basic needs

This Year 2 Annual Action Plan will focus on the allocation of CDBG and HOME funds to address strategic objectives and will also describe the proposed use of other federal and local resources, which are awarded in the same funding allocation process as the HUD grants which include:

Scottsdale Cares Voluntary Utility Donations, General Funds and CDBG for the following :

The City of Scottsdale is distributing funding directly to projects identified as top priority community needs; however eligible proposals submitted outside of these top priorities will still be considered for Scottsdale Cares, General Funds and Community Development Block Grant:

1. Emergency Housing Assistance
2. Crisis Case Management
3. Homeless Supportive Services and Shelters
4. Vulnerable Populations: Seniors and Disabled
5. Positive Development of Youth

Salt River Pima-Maricopa Indian Community (SRPMIC) Funding:

- Senior home delivered meals
- Senior congregate meals

3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

HUD's Office of Community Planning and Development (CPD) seeks to support the development of communities that feature decent housing, a suitable living environment and expanded opportunities for Low-and-Moderate Income (LMI) populations. To ensure Scottsdale strives to achieve this vision, HUD requires annual submissions of the Consolidated Annual Performance and Evaluation Reports (CAPER).

The 2024/2025 CAPER was submitted to HUD and indicated:

- 1,167 low-moderate income families, homeless, seniors and youth were assisted through the public services programs.
- 58 residential households received housing rehabilitation services to help residents remain safe in their home.
- Public Facilities and Infrastructure Program completed the replacement of the Paiute Park Restrooms that will benefit 7,350 low moderate-income residents..

4. Summary of Citizen Participation Process and consultation process

The City of Scottsdale's Citizen Participation Plan (CPP) outlines the efforts the City must take to provide for and encourage sharing input and views from residents, organizations, and other interested parties. The CPP mandates the city publish a public notice at least prior to the public hearing and will announce the availability of the Annual Action Plan in a newspaper and the City Website. In accordance with the CPP plan the following opportunities were provided to achieve the goals of the Year 2 Action Plan and Consolidated Action Plan:

A public meeting before non-profit service providers regarding the 2026/2027 funding allocation process was held on September 18, 2025. A Public hearing before the Human Services Commission was held on February 12, 2026, for the informal recommendations for 2026/2027 funding allocations for CDBG, HOME, Scottsdale Cares and SRPMIC. A public hearing before the Scottsdale City Council was held on April 28, 2026, for vote on approval of CDBG Funds. The public meetings are used to increase awareness in Scottsdale and encourages diverse stakeholders to share their ideas for solutions and uses of the Community Development Block Grant Funds. Community comments were included in the annual goal setting process.

The 30-day public comment process period of the Year 2 Action Plan for July 1, 2026, through June 30, 2027, began on March 27, 2026, and ended on April 28, 2026. The draft of the Annual Action Plan was made available on the City's website, at all public libraries, and the Housing Community Assistance.

In addition to the 30-day public comment period, on February 12, 2026, and April 28, 2026, public meetings / hearings were advertised in the Arizona Republic, and the City's website.

Additionally, online polls allowed Scottsdale residents to comment on the proposed Annual Action activities was posted on the City of Scottsdale website on February 12, 2026, through March 12, 2026, and March 27, 2026, through April 28, 2026.

5. Summary of public comments

The online poll included two Annual Action Plan activities. An Action Plan Discussion and an Action Plan Poll. In total there were 86 participants. The results of the Action Plan Discussion and Action Plan Poll are included in the plan as Exhibit A.

1. Introduction

The City of Scottsdale utilizes federal CDBG, HOME and Housing Choice Voucher programs to assist low-and-moderate income persons. On a local level, Scottsdale allocates General Funds for brokerage services, domestic violence shelter services, legal services, regional shelter services and senior services as well as Endowment funds for community projects and youth programs. In addition, the City allots Scottsdale Cares funds to promote positive development, self-sufficiency and crisis needs. Scottsdale Cares is a utility bill donation program that allows residents to donate \$2 on every utility bill to be provided to social service agencies through a competitive funding process. Salt River Pima-Maricopa Indian Community (SRPMIC) Funds are utilized to support various human service programs including regional shelters and meal programs for the Scottsdale Community.

1. The City of Scottsdale will continue to coordinate with other housing and community development agencies in achieving the goals of the Year 2 Action Plan and the Consolidated Plan, including: Continued participation in the Maricopa HOME Consortium,
2. Continued participation on the MAG Continuum of Care committees and
3. Consultation with the Human Services Commission to review activities of the CDBG/HOME programs.

Scottsdale works with a wide variety of agencies, organizations, and service providers to bring various viewpoints to identify local housing and service needs. Scottsdale is an active participant in the Maricopa Association of Association of Governments (MAG) Continuum of Care Task Force and shares responsibility of the regional solution to the problem of Homelessness. As part of the brokerage services, the city works with Community House, Phoenix Rescue Mission and faith-based partners to address the urgent needs of the homeless through day relief center. The day relief centers offer the homeless the ability to meet hygienic needs, food needs and respite. Phoenix Rescue Mission is at the day Relief Center Tuesday to Friday and Community House is their Monday's.

The City has ongoing relationships with several housing providers working on housing development activities through our Landlord Engagement Outreach activities. The City administers the Housing Choice Vouchers and Specialty Voucher programs funded by the federal government to provide housing subsidies to address the housing needs of the City's lowest income households. Through the Continuum of Care process, the City maintains relationships with mental health providers, homeless shelters, services providers, and other governmental agencies for collaboration to assist homeless individuals and

families. The City also participates in a variety of other coalitions seeking to address other issues that relate to housing and service needs such as the Arizona Housing Coalition.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

City staff works actively with the Maricopa Association of Governments Continuum of Care, the local umbrella for the development of the Continuum of Care. Staff participates in regularly scheduled meetings and point-in-time surveys. In the past, the City has provided administrative support to supplement Continuum of Care initiatives and funding to the various agencies that make up the membership of the Maricopa Association of Governments Continuum of Care. The City employs a Human Services Case Worker who actively participates in outreach efforts and serves on the outreach collaborative committee. Additionally, Scottsdale maintains a license for the Homeless Management Information System (HMIS), enabling staff to enter and access data, track service delivery, and monitor outcomes for homeless programs.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The City of Scottsdale has four (4) priority needs, which are public facility and infrastructure improvements, public services for LMI and special need households, and affordable housing preservation programs. The reasons for allocation are provided below for each priority.

Public services have been identified as a need, however there is a grant cap of 15% allowed for funding public service activities. Eligible persons must be low- to moderate-income (0-80% AMI).

Housing preservation for low- to moderate-income homeowners has also been identified as a priority need. Housing preservation activities do not have a grant cap, and will be allocated around half of the annual allocation. Activities in the housing program include emergency repairs, roof repairs and energy efficiency improvements. The City has also identified affordable housing development activities as a priority in Scottsdale. These activities may include new homeownership opportunities, and acquisition for the purpose of affordable housing; however this goal will not be supported in the current PY 2026

AAP.

Public Infrastructure & Facilities Improvement activities are a high priority. These activities must take place in low/mod areas. Projects are funded as needs arise, and eligible activities may include improvements to streets, sidewalks and water/sewer systems, community centers, and parks and rec facilities.

The major obstacle the City of Scottsdale faces is the general lack of funds to address all priority needs in each annual plan. For example, Affordable Housing Development will not be supported in the current PY 2026 AAP as it will focus on all other priorities. The City will continue to explore additional funding opportunities and using general funds to support programs in this plan.

The City of Scottsdale doesn't specifically allocate funds based on geography, but the funds must benefit low- and moderate-income individuals and families, or be directed towards neighborhoods with a significant low/mod income population. The City uses HUD's definitions to describe its objectives: eligible individuals benefiting from program services are low/mod clientele (LMC); eligible households benefiting from housing activities are low/mod households (LMH); and eligible activities that target a low/mod area (LMA). According to HUD, a low/mod area is a "low/mod block group tract," which is an area where at least 51 percent of the residents are low- and moderate-income persons. However, Scottsdale is an exception grantee, and the "top quartile" percentage of the population is considered low/mod (36%). Additionally, the City provides assistance to low- and moderate-income individuals and households (LMC/LMH) who earn 80% of the Area Median Income (AMI) or less. This assistance is provided citywide and based on eligibility.

Rationale for the priorities for allocating investments geographically

The City of Scottsdale does not to allocate resources geographically but instead based on client eligibility under the CDBG program. As noted earlier, CDBG funds must meet LMC, LMH or LMA objectives.

Direct services such as public services (LMC) and affordable housing rehab benefits (LMH) are based on household income eligibility rather than area benefit. For these activities, City staff and/or one of its subrecipients will complete an application and determine eligibility before the activity is initiated.

Certain activities such as public improvements will serve a low/mod neighborhood or area (LMA), and have an "area-wide" benefit. Per HUD requirements, these areas must be within an eligible Low/Mod Block Group Tract, as defined by HUD-CDBG regulations, whereby the majority of the residents are low- to moderate-income. As noted above, Scottsdale is an exception grantee, and the "top quartile" percentage of the population is considered low/mod.

To determine LMI tracts the City utilizes HUD's CDBG Low Mod Income Summary Data (LMISD) from the HUD Exchange website, which has defined the eligible block group tracts within the jurisdiction. The

Discussion

The distribution of funds by target area is projected to be primarily citywide due to use of funds for non-profit support and individual benefit-oriented programmatic uses of the funds. The remaining funds are estimated to be spread through smaller CDBG-eligible areas.

- Rental assistance (Housing Choice Voucher Program)
- Tenant Based Rental Assistance
- Landlord Engagement Initiative
- Explore property acquisition of affordable rental property
- Maintain the affordability of Bellevue property

Actions planned to reduce lead-based paint hazards

With the establishment of the City's Homeowner Housing Rehabilitation Programs, Scottsdale has developed procedures for identifying homes with lead-based paint and treating them in compliance

with the Residential Lead-Based Paint Hazard Reduction Act of 1992 (Title X) and subsequent changes in September 1999.

An estimated 33% of all owner-occupied units and 27% of renter-occupied were built before 1980 (Source: 2018-2022 ACS). That's over 25,000 owner-occupied and 10,000 renter-occupied housing units. Any household with a child under the age of six receiving federal funding and living in a pre-1978 housing unit requires lead-based paint testing be performed.

Scottsdale will continue to test homes constructed prior to 1978, receiving federal assistance, for lead-based paint in compliance with 24 CFR part 35, at the time households seek assistance from the City. Additionally, all program participants are provided the required lead-based paint brochure and;

- Continue to meet HUD lead-based paint abatement standards in housing rehab programs.
- Seek additional funding as it becomes available to provide testing and abatement of lead-based paint hazards in single-family housing where young children are present.

Expand the stock of lead safe housing units through housing initiatives.

Actions planned to reduce the number of poverty-level families

The City will take the following actions to reduce the number of households living in poverty:

- Provide funding assistance to non-profit providers of services to Scottsdale's youth, seniors, special needs populations, victims of domestic violence, persons and families in crisis, and disabled persons.
- Address increased needs through best practices in management of programs, funding, facilities, and license agreements.
- Improve quality of life through connectivity-people to services
- Provide access to basic needs.
- Tenant Based Rental Assistance through HOME funds
- Provide prevention and assistance through:
 - Intake and referral;
 - Emergency rent and mortgage assistance;
 - Emergency utility assistance;
 - Career counseling;
 - Promote self-sufficiency, mitigate the causes of poverty, and support independent living through

the Family Self-Sufficiency Program (FSS);

- Improve quality of life through education, recreation, and socialization.

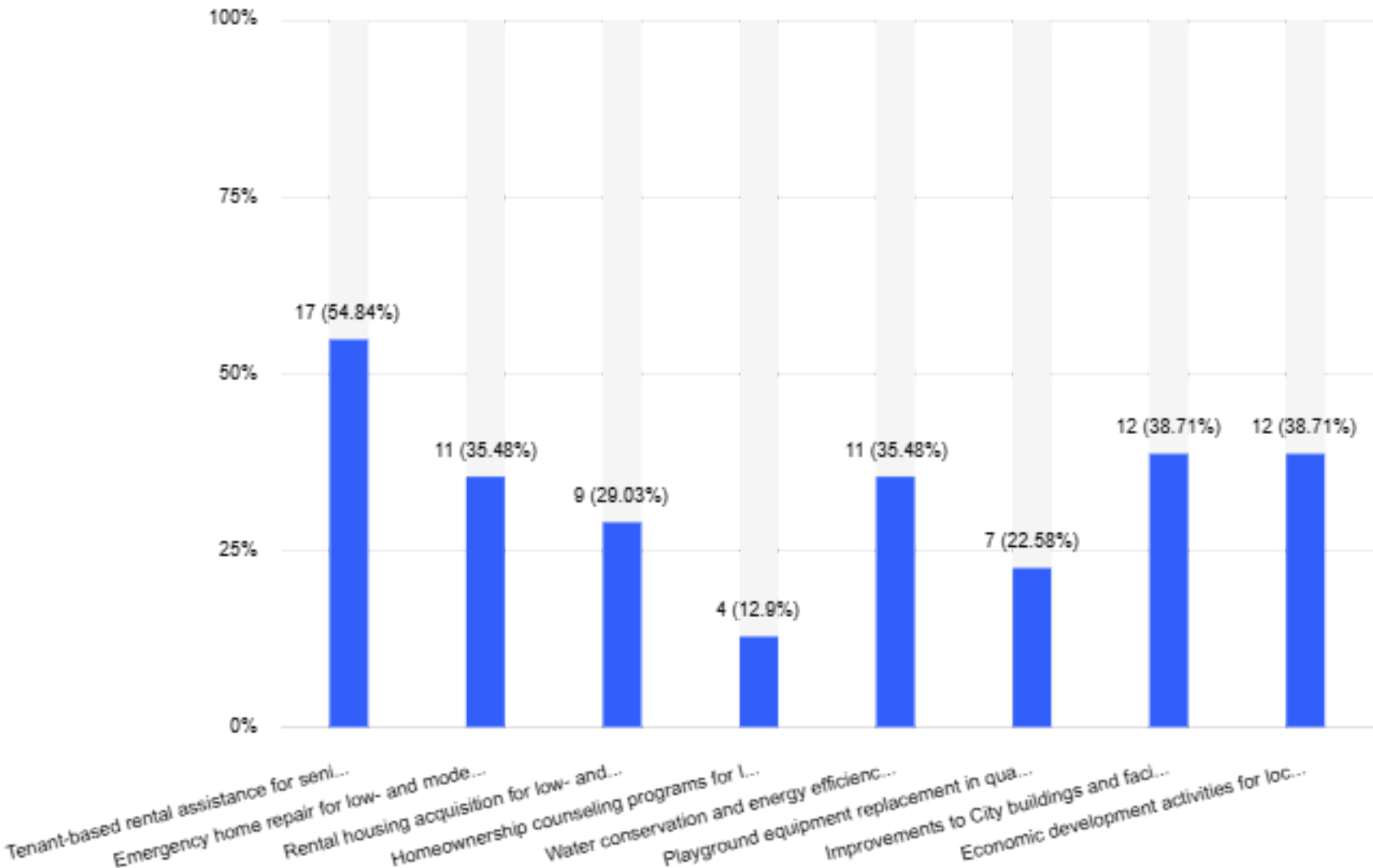
