The Surrey County Council
Proposed 20MPH Speed Limit in Various Roads in Cranleigh

Surrey County Council propose to make “The Surrey County Council D664 Parsonage Road and Various Surrounding Roads in Cranleigh (20 mph Speed Limit) Order 202-”, under Section 84 of Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to impose a maximum speed limit of 20 miles per hour on the entire length of the roads in Cranleigh specified in the Schedule to this Notice. The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
